PRESIDENT'S REPORT



President's Annual Report for Lutheran Church of the Resurrection 2022

It has been a blessing and a privilege to serve this year as the Council President. We have an active and hardworking Council that has accomplished much this year. Their positive attitudes and commitment to getting things done makes my job easy. I want to thank them for all their accomplishments this year. I also want to thank the office staff for their support.

Working with Pastor Jeff as senior Pastor has been easy and educational. One of the first things he taught me when I started to talk about growth was "A healthy church will be a growing church and you cannot grow unless you are first healthy." This is a great mantra to follow. I believe we are, in general, healthy, and certainly are growing.

This year we have focused on the two goals of Outreach and Fellowship which are really intertwined as we bring in new members and integrate them into the congregation.

The Outreach team has strengthened existing programs and started several new ones. Neighborhood Nights has been a big success, with approximately 250 attending each month. Our monthly Car Cruise-In events bring a steady flow of people into our building for pizza and pop, and give us a chance to meet them. The Outreach team organized the quarterly Council Brunches. They also organized the one-time events - LCR Car Show, Rally Day and the Tony Jones Weekend Breakfast.

On the fellowship side we have Bingo, Father's Day Breakfast, Ministry Fair, and a Sunday morning Mom's Group. All in all, the Outreach/Fellowship Team has had a very successful year and will continue to add programs in 2023.

The Property Team also had a great year. Property Team has started looking at strategic planning for future projects as well as funding for those projects. This building is now 19 years old and we can expect some fairly large maintenance costs in the future. Once again this year we will set aside \$10,000 to prepare.

The team completed the replacement of all our lights with new LED bulbs which should save us approximately 10% on our electric bill. Vendors were reviewed and a new electronic messaging sign has been ordered from Cedar Rapids Signs. Our internet server, internet, and phone system have been switched from Mediacom to ImOn with better performance and significant cost saving. Windows in the garage have been replaced, wiring outlets added, doors refinished, and the educational wing repainted. We have a cadre of dedicated members who quietly get these tasks done. Thanks to them.

Finance keeps doing what they do well every year - giving the Council an accurate and informative view of our financial situation, organizing the stewardship drive, and preparing the annual budget. As a non-financial guy I really appreciate all the hard work they do without a lot of recognition.

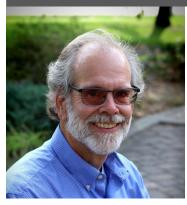
Governance has the task of making sure we are in compliance with all areas of employee procedures, Synod guidance, and insurance processes. We did develop a responsibility matrix, as well as an abbreviated call process for calling Pastor Nate. An in-depth audit team is reviewing all our processes for best practices, with a completion date of 2023. A review of the employee manual will be on the agenda for next year.

Being the Council President has been an enjoyable and rewarding experience. The combination of Pastor Jeff and the active Council members has been great. Would you believe we actually have a lot of humor and joy at Council meetings?

SENIOR PASTOR'S REPORT



Annual Report of the Congregation - Pastor Jeff Frohner

"For we are God's coworkers, working together; you are God's field, God's building." 1 Corinthians 3.9

While the context of the church in Corinth leads the Apostle Paul to use the image of being "God's coworkers" to refer to himself and other leaders, I want to suggest that by virtue of our baptism all of us should consider ourselves coworkers with God for the sake of the Gospel of Jesus Christ. The paradox becomes then that we are both coworkers with God while at the same time being God's field and building that needs to be tended. This is something that Lutheran Christians are quite familiar with: we are both saint and sinner; those who forgive and those in need of forgiveness; we are those who need to be healed and those who offer healing to others; we are those who grieve and those who bring comfort. I think this can be a helpful image as we think about who we are at Lutheran

Church of the Resurrection, where we place our resources, and how we continue to be a healthy place that both actively welcomes others, and a place, because of our spiritual wellbeing, that is attractive to others.

In reverse order, we "are God's field, God's building."

Just as a field or a building requires routine maintenance and the occasional renovation - we neglect the disciplines of the Christian life to our own peril. Worship, study, fellowship, and prayer are at the core of these traditional disciplines that keep us healthy and grounded in Christ. We might think of these things as 'in-reach' for our own spiritual health and wellbeing.

--Worship: While stylistic preferences might be different for folks, at the heart of worship is "the Gospel purely taught and the Sacraments correctly administered" (Augsburg Confession Article VII). Online worship continues to be an important tool for us as a congregation, however it does not replace our weekly physical coming together around Worship and Sacrament. You have the commitment of your pastors that when we gather for worship we expect the Holy Spirit to be at work, 'calling, gathering, enlightening, and making holy' each and every one of us (Small Catechism, explanation of the third article of the creed). I implore you to come to worship expecting God to be at work - the Holy Spirit nudging at your heart and your mind. Taste and see if indeed God is good and present when we come together (Psalm 34.8).

--Study: Lutheran Christians were born in the university and we are not afraid of learning and intellectual pursuits. Christ after all has come to take away our sins, not our minds. This past year we invited Dr. Tony Jones to come and be with us and I am hoping to carry this forward each and every fall as we bring engaging theologians to come and speak about being people of faith in the world. We have several opportunities for Bible study and small group experiences as well as a wonderful resource in Pastor Nate and his expertise in Lutheran Confessions. Our Sunday school and youth programs are committed to help our young people engage with scripture and find the living Christ and promises of God. Let's be honest there are lots of people who would lead us down questionable paths. Scripture warns us about "itchy ears" and how we can all too easily be drawn only to that which serves our own desires (2 Timothy 4.3-4). It is important for us to understand what we believe and why. It is my hope that you will take advantage of the opportunities for Christian education that are theologically sound and confessionally faithful in order to strengthen your own faith and be able to commend the faith that you have to others (1 Peter 3.15).

--Fellowship: We need to play more. I don't think we can take for granted how powerful a strong Christian friendship can be in the life of the faithful and in the health of a local congregation. Let us not forget, that God is equally present when folks laugh and enjoy an outing, as God is when we gather around to study scripture. The church can be a place where lifelong friendships develop and we need to be more attentive to that. My prayer is that someone who is reading this might take this to heart and be the catalyst for an LCR Sports team; an annual picnic; an occasional "Family Outing" event; a trip to a Hockey Game; a group that goes to the theatre; an LCR Family Camping weekend; an LCR Ragbrai team. We need to play together. We need opportunities to get to know one another so that we can be of mutual benefit to each other. Some of us here at LCR are very connected; others of us are not. In a similar way we need to cherish our ability to be an intergenerational community. Our world has tended to segregate the generations and a church like LCR remains one of the few places where a 2 year old and a 98 year old can participate in the same thing. Let's be intentional about fostering our intergenerational connections. If you are an older saint, take it upon yourself to learn the name and say hello to at least 2 new younger folk this year. And likewise if you are a younger saint, reach out to some of our elders to foster those connections.

SENIOR PASTOR'S REPORT

--Prayer: The Psalmist reminds us "to be still and know that I am God" (Psalm 46.10). It is often in the stillness that we find a moment to center ourselves, to remember who and whose we are, to gain some needed perspective that will help us navigate the path ahead. When you pray don't just ask for things (you can do that, I have a long list as well); but ask for God to help you see as God sees. Ask for the strength to be more like Christ and to see others as God sees them. And pray for our church. Please pray for Pastor Nate and myself and for the welfare of all the staff and leaders at LCR. Forgive us our shortcomings and hold us up - it is vital for all of us to know that we are in prayerful support of one another.

"We are God's coworkers."

This is where we get the joy of living out our faith in the world. This means that each of us is a part of the body of Christ and that together we can do wondrous things! These are the areas of "outreach" where we work with God as co-creators in bringing light and goodness to the world. We do this by reaching out locally, globally, and selflessly.

Locally: From my first days here at LCR I felt that God was calling us to be a "Neighborhood Church." I have a simply definition of what that means: A neighborhood church is a place where the majority of people within the surrounding neighborhoods can identify a specific outreach or ministry that has a positive impact on the community. It should be our goal to be known in the neighborhood as a hospitable place where people are welcome. Neighborhood Nights, monthly car cruise-ins, Friday Gatherings, cribbage, and dominos, special speakers, Annual Car Show, Vacation Bible Camp, Vacation Bible School, hosting Scouts, hosting homeowner association meetings are all examples of being a visible neighborhood church. We all know that a church is not simply a building; nevertheless our building is an important asset in providing a safe, welcoming venue in which to invite others. As our building and infrastructure ages (over 20 years) we will need your dedicated support to both carry out our ministry and to maintain our facilities.

Globally: I am going to use this word a bit differently than you might assume. To act globally is to be concerned about those issues of human need that are universal - and then doing our best to address them both here in our community and around the world. We do a tremendous job on this front. Thank you. I take seriously Pau's metaphor of the church being the body of Christ, and each of us are members of it. That being said, we don't all think alike or support the same causes; but we do wholeheartedly support our call to love one another and to see in others the face of Christ. This means that we don't just have one or two 'special pet projects' or rally behind the current cause of the day - but we are steadfast and relentless in our understanding that to those whom much has been given, much is expected (Luke 12.48). When a congregation forgets to be committed to good work outside of its door, it is then that a congregation begins to die. So we will continue to offer you opportunities to provide for others: food collections, financial donations, clothing and personal item collections, walking with our local school districts, providing meals, aiding victims of war and aggression, disaster recovery, mission activities, and support of refugees and the impoverished.

Selfless: I will use this word differently as well. We do everything here at LCR because of the surpassing value of knowing Christ Jesus as Lord (Philippians 3.8). We are not seeking to be the biggest church, or have the flashiest programs, or build our own little kingdom where we can bully and buy our own way. We do everything for the sake of Jesus. I know this sounds pious, but it is the only reason I am able to serve as a pastor.

We are called to be faithful - not nice. What I mean by that is we are called to be stewards of the congregation, not any one person's whims or desires. We are called to be faithful to the proclamation of the Gospel, not any one way of doing things - no matter how well those things may have served us in the past. I believe this is why the Apostle Paul

so vehemently warns us "Put away from you all bitterness and wrath and anger and wrangling and slander, together with all malice" (Ephesians 4.31). These are the things that are a sure and certain sign that we are not being selfless - doing all for Christ - but have begun to get turned in on ourselves. I am so pleased that here at LCR you are a selfless congregation and I implore us to continue to keep that the expectation. This will lead to health; and healthy things grow in all kinds of ways.

As we enter this new year of ministry may we tend to the "field and building of God;" keep ourselves fit for the work of the kingdom (1 Thessalonians 2.12). And may we take seriously our call to be "God's coworkers" as we live out our faith here at Lutheran Church of the Resurrection.

STEWARDSHIP

The LCR Stewardship Team met monthly to discuss the financial status of the Church and consider whether actions were needed to adjust future expenses based on current revenue. With the challenges of the COVID -19 pandemic and 2020 Derecho largely behind us, no significant changes to planned spending were required. In the Fall timeframe, the team focused on the 2023 Fund Appeal and the 2023 LCR budget. Changes to the budget included adjustments for staff and programs, as well as funding for the sign replacement. Details are in the Annual Report financial pages.

The Stewardship Team also continued to review quarterly financial reports of the Living Legacy Fund (Trust Fund) under LCR Constitution and Bylaws changes approved at the Annual Congregational Meeting in 2020.

The 2022 Fund Appeal packet was developed around the theme "It Is Good" by a small task group. The group consisted of Stewardship Team members, staff, and congregation volunteers with the help of Pr. Frohner. The Fall Appeal material was made available electronically, if indicated by congregation members, or by postal mail and distributed in mid-October. Over 150 families opted for electronic (e-mail) delivery, so packet printing and mailing costs were saved. The Appeal results are summarized below.

Tally of 2023 pledges as of Jan 11, 2023:

196 pledges received (59.8% of giving units)	\$652,708
Special one-time gifts	<u>\$ 4,230</u>
Total	\$656,938

For comparison, the pledge tally from the same time period in 2022 was:

196 pledges (56.5% of giving units)	\$593,877
Special one-time gifts	<u>\$ 7,150</u>
Total	\$601,027

We started 2022 with a large surplus thanks to the faithful giving of our members, unused pandemic-related funding from 2021 that carried over, and careful management of expenses. That surplus was approved to fund a larger budget in 2022, which helped support the call of a full-time Associate Pastor, ongoing facility upgrades, and contribution to a reserve fund for unexpected facility maintenance items. With continued faithful giving and expense management we ended the year with the surplus unused again, enabling it to carry forward to 2023.

PROPERTY ADVISORY AND PLANNING

The team acknowledged that the building is starting to show its age and we've seen a number of areas and systems within the building that are failing. The team decided to triage the list of repairs and upgrades to give the congregation the best bang for our buck with our budget. Below you'll see many projects that were taken on this year and even some work that was prepared and planned for coming years.

The exterior lights have been replaced with LED lights. These will have reduced the amount of energy required and lengthened the bulb replacement time to last longer. Initial savings have so far offset the rising costs of energy.

One of the final Derecho-related damage repairs was the garage siding and windows. This project was completed this summer, and that garage is in good repair again.

After a long-dormant hiatus, the church van had been serviced and is ready for use again. Several groups have already been able to take advantage of this.

The team identified several areas where our building is settling and needed to repair the drywall. These have been completed and a refreshing coat of paint was applied in many rooms before Sunday school started this season.

We have assessed the ISP service and have switched to Imon, improving our upload speeds for streaming our services and other general use. Switching to Imon benefited us by reducing our monthly cost as well. Our office has switched to a VoIP phone service which has reduced our costs and improved some phone performance that the staff had.

The team looked at carpeting, got some quotes, but acknowledged that there are severe floor cracks that will add to the cost. Repairing those floor cracks needs to be timed with the carpet repair and is planned to be deferred until 2023.

Several furnace and AC repairs were completed this year. Long term, the team is planning to look at creating plans to better predict failures, but also when to replace systems, not just repair them.

We have also contracted to have a new electronic sign installed in 2023. There was an information session on the details, costs, and trades between vendors. This is a large expense but is a necessary first impression

on thousands of cars of traffic daily that drive by our building. The costs have been split between 2022 and 2023 budgets. Thank you to all in the congregation who have earmarked additional funds for this project . This really shows how important you all think this is.

I want to thank the Property Advisory & Planning Team members for their hard work and dedication. This team's gifts have provided leadership, skills, and labor to make all of these projects come to fruition.

The Outreach Team is responsible for helping to facilitate and coordinate accomplishing this mission. - Organizing and leading a monthly intergenerational BINGO event November-April
- Supporting Neighborhood Nights programming
- Serving at monthly Car Cruise-Ins May-October
- Hosting a Lutheran Church of the Resurrection Car Show
- Establishing and leading a weekly Mother's Group to connect mothers of all ages and stages of parenting
- Organizing and staffing quarterly Council-sponsored breakfasts to increase Council's presence in the congregation and connect people from the whole congregation
- Organizing and serving staff breakfasts
- Supporting the Ministry Fair, designed to connect people to their gifts & talents

Moving forward, the committee plans to:

- Add more individuals to the Outreach Team, in hopes to increase our presence and outreach opportunity
- Continue to engage the congregation in volunteer efforts to support programming
- Continue to support Neighborhood Nights as an outreach to the community
- Continue and expand outreach activities such as BINGO and car cruise-ins
- Continue connecting members of the congregation through congregational breakfasts
- Work with the congregation to build raised beds and begin growing a garden.

We encourage everyone to return their pledge forms.

You may also give special offerings electronically using the LCR website via PayPal or Venmo. Just let us know where you would like your donation to go.

AUDIT COMMITTEE

General Fund, Clearing and Growth & Outreach Accounts. The committee compared the December Council report to the December bank reconciliation. The committee randomly selected two test months: March and August. Evelyn Beck provided documents. The committee compared the checks written and checks cleared to the check documentation, account activity register, bank statement, and Council Summary with no exceptions. The disbursements appeared reasonable and fit the ministry's purpose.

Quilters. Harriet Van Gilder provided documents for the audit. The checkbook balance matched the annual report and bank reconciliation at the end of the year. Deposits and distributions were reasonable amounts for items that fit the ministry purpose. Receipts were present for distributions and the deposit from LCR matched the disbursement on LCR's books.

ELCW Circle. Harriet Van Gilder provided documents for the audit. The checkbook balance matched the annual report and bank reconciliation. Deposits and distributions were reasonable amounts for items that fit the ministry purpose. Deposit amounts matched offering recorded from LCR.

Trust fund. Joan Meyer provided the trust fund statements, checking account statement, and checkbook ledger. The ending balances trust fund investments listed in the trust 2021 treasurer's report were compared to the Farmers State Bank checking account, ELCA Mission Investment Fund CDs, and ELCA Endowment Fund Pooled Trust. One check was written to Lutheran Disaster Response for \$1,000 and matched the amount given in the annual report. All other checks were for scholarships and matched for all designated recipients in either the 2020 or 2021 annual reports. The Mission Investment Fund interest was entirely deposited and accounted for in the checking account. Records indicate all income in the endowment fund was reinvested.

The 2021 Trust Fund ending balance was \$218,344 vs. the \$214,339 reported in the annual report. This is \$4,005 more than the 2021 annual report only because the ELCA Pooled Trust Fund December statement balance was not received in time to be included in the annual report.

General Internal Controls. Last year the audit committee recommended establishing a committee to review the LCR's accounting system procedures. After discussion with the Council, the committee expanded the

audit in 2022 to start documenting the system. Although this will be a multi-year process, in order to strengthen internal controls over cash disbursements now, the Council has approved requiring dual signatures on checks beginning in 2023, as recommended by ELCA Financial Best Practices for Congregations. In 2023 the audit will continue the review of accounting software and financial reporting, insurance coverage, timely filing of State and Federal payroll tax forms and State biennial report, the accounting for the City lease and Wee Wisdom Preschool use of LCR building, and the record retention policy.

TRUST FUND

(LIVING LEGACY FUND)

The Living Legacy Fund continues to have four associated funds.

- Biderrman Scholarship scholarships for high school seniors
- Seminary Scholarship scholarships for seminary students
- Education grants for pursuing religious learning opportunities and funding for congregational programs
- Benevolent Giving support for mission partners

In 2022, the Fund awarded three \$800 scholarships to graduating high school seniors - Megan Heidelbauer, Nicholas Sanders, and Ray Redondo - from the Biderman scholarship fund for the 2022/2023 school year. Students who are LCR members and high school seniors may apply for the Biderman scholarship in March each year.

This year the Fund supported "The God of Wild Places" with Tony Jones, with several activities scheduled over a weekend this November. This was the first program funded through the new Education Fund.

During Lent this year the Benevolent Giving Fund matched contributions from the congregation and made a \$2,500 contribution for the well water project at Camp Chisomo. During Advent we matched \$1 for each food item donated by the congregation, up to \$1,500, during the Reverse Advent Project. The project was very successful, with donations of over 1,800 items, so the Living Legacy Fund added a \$1,500 check to our delivery to the Churches of Marion Food Pantry.

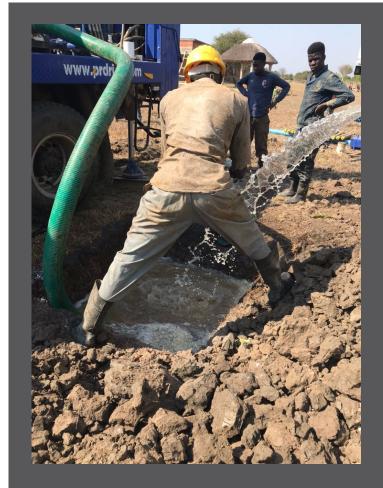

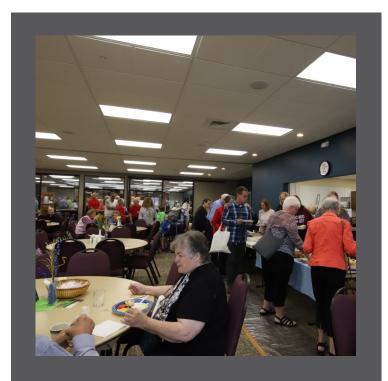

FINANCIAL REPORTS

INTRODUCTION TO 2023 BUDGET

I. Review of 2022

- Our original receipts estimate was \$710,000 a 3% increase from 2021 totals
- 2022 receipts were \$760,043 or 107% of our target of \$710,000
- 2022 expenses were \$700,927 Or 92% of our 2022 budget of \$759,476
- We began the year with \$242,163 in the combined funds and ended the year with \$341,590
- On average we receive 100% of pledges as income and we base future receipts projections on that pattern. In 2022 we received 103.8% of pledges as income, compared to 102.4% in 2021
- Takeaway Receipts were higher this year as we added many new members to the LCR family and

members continued to give faithfully. Expenses were lower as we resolved staff openings throughout the year and continued efforts to be faithful stewards of our resources. As a result we did not have to use our excess cash to make up the difference between giving and expenses as proposed in the budget.

KEY HIGHLIGHTS OF THE PROPOSED BUDGET

Mission Partners

In 2022 we gave 10% of total giving of \$79,390 to the following global and local mission partners: ELCA Southeastern Iowa Synod, Take Away Hunger, Habitat 4 Humanity, Camp Chisomo, Jail Chaplaincy, Mission of Hope Meals, Marion Cares, Lutheran World Federation (Ukraine relief), Marion School Foundation (clothing and shoe drives), Willis Dady Emergency Shelter, ELCA World Hunger, Freedom Foundation, F.L.Y., Churches of Marion Food Pantry, Community Free Health Clinic, Catherine McAuley Center, and Matthew 25. It is our intention to give 10% of total money received in 2023.

Pastoral Compensation

Pastor Jeff's and Pastor Nate's wages will continue with no change in compensation.

Lay Staff Compensation

A 2% cost-of-living adjustment has been applied to all lay staff for 2023.
