President's Annual Report for Lutheran Church of the Resurrection—2024

As I reflect on the past year as council president, moments that made impressions on me and gave thought to preparing this yearly report, a specific word and theme seemed to keep resurfacing - it might sound odd but hang in there with me on it. The word was one that's been discussed in several sermons this past year and one that I started giving a lot of thought to. The word is 'repent.' Even typing it I can hear Pastor Jeff saying "It just means turn around!" That definition opens so many possibilities and really seems to capture the spirit of how most of us approach January. I also think it grabbed my attention through the year because I love the idea of applying a different connotation to the word than I think most of us associated with it historically. So - here are my thoughts as I repent, joyfully, and turn around to look back and reflect on the past year, turn around to look

forward in faith toward the future, and turn around by thinking about choices that might be different than those we've made in the past.

We reached out into the world supporting programs like the ELCA Global Barnyard and multiple disaster relief efforts. Our community is better in tangible ways because of these ministries and many more!

In looking forward I know that in the coming year this congregation will continue to grow in size, in faith, and in fellowship. We'll continue to educate and enrich our kids' faith journeys through our excellent youth programming, from laying foundations with our Wee Wisdom Preschool, through Sunday school, VBS and Day Camp programs, middle school and confirmation groups, and into adulthood through our EDGE youth group. We'll also continue to support our congregational community through our many excellent music, adult education, and fellowship/hobby groups.

SENIOR PASTOR'S REPORT



Annual Report of the Congregation - Pastor Jeff Frohner

"Let your eyes look directly forward and your gaze be straight before you." Proverbs 4.25

I've begun to find more interest in the book of Proverbs. The main concern of Proverbs is the pursuit of a happy and good life on earth, lived in the context of a faithful calling. It is incredibly practical. The wisdom from Proverbs comes from what a person observes and from experience.

I have served as a parish pastor for over 30 years and my experience has taught me that congregations that are healthy and sustainable learn to embrace the present and not romanticize about the past. They are looking forward to where it is that God is at work

and the Gospel is compelling them to be, as opposed to lamenting the changes in culture and longing for what was. The work of the local congregation is to keep our eyes directly in front of us as we look to share the love of Jesus in our community and beyond.

So, what do I see in front of Lutheran Church of the Resurrection?

First some very practical matters. I still at times hear folks talking about the "new building!" Well, it is now over 20 years old. There is a trap in putting the main emphasis on buildings and structures. There is also a deadly trap in not keeping up with deferred maintenance. Our current church building allows us to do ministry - so it is vital. Not for its own sake, but as a tool at our disposal that we have been given and trusted to take care of as good stewards.

You will see in this year's budget some items that are not very exciting, but necessary. Replacement of HVAC components, asphalt repair, concrete lifting and repair etc. Keeping our eyes forward will mean being proactive about these things and supporting their completion. It would not be unreasonable to assume at least 10% additional impact on our budget will be needed yearly for keeping up with ongoing maintenance. I see us being good stewards together to maintain our physical assets.

Connected to this is what I can only call "curb appeal." I know it sounds shallow, but people pay attention to how a church looks and is maintained. While our building is very functional it does not offer the layout committed to hospitality that many people are used to seeing in newer churches. (Large foyer space that clearly connects to all ministry areas, large entry way which welcomes newcomers, clearly highlighted children's space, etc.). This means that we need to invest in making sure our space is well maintained and reflects our care and passion for ministry. These are not frivolous items but help us to be inviting and ultimately reach our goal of making disciples for Jesus.

I see important conversations about these things that are not based on personal preferences or 'sacred cows' of the past - but on what will help us proclaim Jesus moving forward.

I see a church that continues to value church health as the means to viable and thriving ministry. Church health begins with a culture that puts a low value on drama, dysfunction and division and a high value on integrity, competence and shared vision. Of course, we all fall short of the glory of God (Romans 3.23) and yet we balance that with a desire for excellence in all that we do (2 Peter 1.5). I see a road ahead where we are not afraid of making mistakes or risking for the sake of the Gospel; but always leaning into the continued presence of the Holy Spirit to renew and lead us. I also see this honest and healthy approach to being the church as appealing to others who are quite frankly tired of the distractions from ministry that can so easily envelop a congregation. I see continued congregational health.

I see an opportunity to grow in our children's and youth ministry. This year we are excited that Jessi Lau (Director of Children's Ministry) will add to her portfolio an emphasis with Junior High youth and a fuller integration into the life and ministry of LCR. This is an area of ministry that will benefit from more intentional focus and engagement. I also see a vitalized effort, lead by our new High School Youth Director Hannah Sherbon Powell, to engage our High School Youth with more service opportunities and access to events and programs that will strengthen our ministry and help develop young followers of Jesus who are grounded in faith and connected to LCR as they move into young adulthood.

I see you. I see you growing in discipleship, finding strength in Word and Sacrament and going out into the world with a faith that is active in love. We live in a culture that promotes and expects "programmatic church." I understand this, and we will continue to provide ministry programs here at LCR. But what I really see as life changing in the world is a congregation that gives you the confidence to bring your faith into your sphere of influence. I see a church that is filled with people of different opinions, sensibilities and perspectives that are made better by our mutual affections, grounded in faith and then go out to bless the world. We are not a 'country club' but more of a 'watering hole' where folks can be renewed and filled with the Spirit to go out and be the people of God. Church cannot be an end in and of itself but a means by which the people of God are equipped for life in the world.

Both Pastor Nate and I enter 2025 with a sense of excitement and joy in ministry. Together let's keep our eyes forward, always looking for the good, looking for Jesus, looking for opportunity to let our light shine.

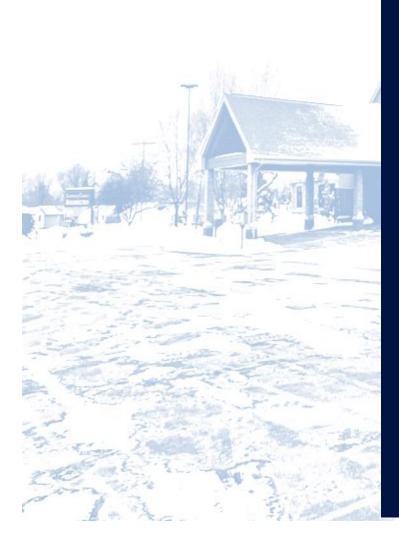


GOVERNANCE REPORT

With the continued growth of our Children and Youth Ministry Programs, along with Wee Wisdom becoming a department under LCR, we elected to review and update the Youth Protection Policy. We met with Jessi, Nate, and Katie to review the previous two policies the church has used. The team discussed their current practice, items they wished were included, and procedures that needed to be updated with changing times. A new draft was written which consolidated a few policies into one. It was sent off to an Employment Lawyer with Shuttleworth and Ingersoll Law Firm for review, to ensure we were meeting current legal recommendations. The final draft was reviewed by Council and adopted on 09/17/2024.

OUTREACH

The Outreach Team is responsible for helping to facilitate and coordinate accomplishing this mission. As a team, we link people to serving opportunities, connect people's talents with community needs, create a culture of invitation, continue to expand our physical and virtual presence, promote a culture of hospitality, and make it easy for people to help people. We accomplish this by helping people see and know God through our work, kindness, and genuine concern for their spiritual and physical well-being. We lead by example, and it is our prayer the church community will grow through the congregation's actions.

This past year, we embraced the mission of connecting people to LCR by:

- Supporting visitor hospitality by providing personalized visitor bags and volunteer shirts
- Organizing and leading a monthly intergenerational BINGO event October-April
- Supporting Neighborhood Nights summer programming
- Serving at monthly Car Cruise-Ins May-September
- Hosting a Lutheran Church of the Resurrection Car Show in July
- Organizing and staffing quarterly Council-sponsored events to increase Council's presence in the congregation and connect people across the whole congregation
- Planning and hosting the 2nd Annual LCR Summer Picnic and pulled pork competition
- Supporting the community garden ministry to aid the Churches of Marion Food Pantry
- Organizing church staff events and staff recognition
- Supporting the Ministry Fair, designed to connect people to their gifts & talents
- Hosting a community Trunk-or-Treat event

Moving forward, the committee plans to:

- Add more individuals to the Outreach Team to help us continue to increase our presence and outreach opportunities
- Continue to engage the congregation in volunteer efforts to support programming
- Continue to support Neighborhood Nights and annual Trunk-or-Treat as outreach to the community
- Continue to support outreach activities such as BINGO and Car Cruise-Ins
- Continue connecting members of the congregation through council sponsored events
- Work with the congregation to explore establishing a church historian or historical society
- Work with the congregation to sponsor a 'Fall Into Marion' Parade float to support community visibility

PROPERTY ADVISORY & PLANNING

What a fulfilling year this has been for the Property Advisory and Planning Team. Wee Wisdom room refresh, to HVAC updates, to parking lot crack-filling, oh my! See below for more details.

The largest project this year was the renovation of the Wee Wisdom classroom. Cabinets were removed and relocated, and the unused accordion wall was completely removed to create more floor space for the classroom. All walls were repainted, including the preschool office and bathroom. New blinds were installed and window trim refinished. The old tile floor was ripped out and replaced to remedy the large floor crack. Future plans include new cabinets to replace the dated and worn cabinet/counter tops. Special thanks to Nyla for leading the design changes and Marlin for enlisting the crew to replace the trim along the floor. We appreciate everyone who contributed to get the work completed in time to start the new school year.

For heating, cooling, and ventilation, more work was needed this year as our 20+ year old building is starting to show its age. Our saga with the sanctuary air conditioner flooding the gathering space continued again this year. Many thanks to the volunteers who helped manually drain the catch pan until a fix could be found. We partnered with Fosters-Kraus HVAC who ultimately diagnosed and implemented two ways to prevent water from falling through the ceiling. We have also contracted Fosters-Kraus to provide twice-annual maintenance checks on our entire HVAC system. It was determined that 2 of our 9 original furnaces needed to be replaced due to worn heat exchangers. We are planning on replacing the rest of the furnaces over the coming years.

The parking lot continues to be a work in progress for us. Last year was focused on repair. In the fall the property team, led by Marlin, worked to seal cracks all around the lot. 30+ gallons of crack seal were applied! A combination of leaf blowers, brooms, loose gravel, and Marlin's ingenuity inventing a crack seal applicator all contributed to this effort. Next up will be sealing the entire asphalt parking lot and re-painting parking lot lines. We are also contracting with Mid-America Basement Solutions to raise and level sections of our concrete sidewalks and patio areas in the spring of 2025. They use a foam-based system to raise and level the concrete sections. Additionally, there will be a sealant applied between raised concrete sections to minimize water erosion and extend the life of the concrete raise. Future concrete work may include creating additional handicap ramp sections.

Last year's garage door damage and subsequent repair has driven the need for additional security cameras. Four new cameras have been installed, with two on the garage itself. Additional cameras monitor the front of the church, including one keeping an eye on our new digital sign.

A quick update for those following along on our energy efficiency efforts, led by Bob Erlandson: Previous years' effort was made to convert most of our lighting to more efficient LED bulbs. Our electricity usage in 2024 was approximately 15% less, resulting in savings of approximately \$1,500 annually. Future plans for further energy efficiency will be replacing our thermostats to synchronize operation and limit peak-loading, which will also help drive down our annual electricity usage. The team is now seeking information on installing solar panels to the roof of the church to offset approximately 50%

of our electrical usage per year. This could result in saving \$6,000-\$7,000 per year in annual electricity costs! More information will be provided to the congregation before a decision can be made to move forward.

I want to thank the Property Advisory & Planning Team members for their hard work and dedication. LCR GARDEN REPORT 2024

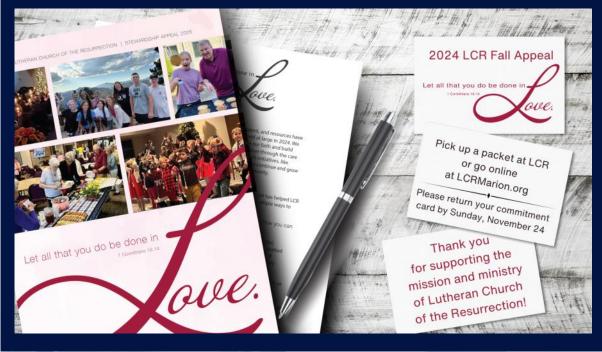
LCR Raised Bed Gardens produced 1,429 pounds of fresh vegetables for the Marion Food Pantry in 2024. Produce was planted, nurtured, and harvested from 292 square feet of raised beds and 180 square feet of open vine area.

Thirteen LCR members signed in to work at the gardens, with Ann Godar leading the way with 30 sign-in days. Plans for 2025 planting are already on paper, waiting for Spring and volunteer workers. If you like to garden with good people and are available - at times of your choosing - let the church office know of your willingness to help provide fresh produce to our community through our support of the Churches of Marion Food Pantry.

STEWARDSHIP

Stewardship is a practice that embodies the responsible planning and management of resources. The LCR Stewardship Team met regularly throughout 2024 to monitor the financial condition of the Church and consider whether actions were needed to adjust future expenses based on current revenue. In the fall time frame, the team focused on the 2025 Fund Appeal and the 2025 LCR Budget. Changes to the budget included adjustments for staff and programs, as well as increased budget for facility repairs and maintenance. Details are in the Annual Report financial pages.

The 2025 Fund Appeal packet was developed by a small task group around the theme "Let all that you do be done in love." The Appeal resulted in pledges as of December 26th of approximately \$706,000 (210 pledges, which is 63% of giving units). Last year, pledges at the same date totaled \$691,000 (208 pledges; 63% of giving units). This is a 2.2% increase in pledged dollars, which is less than the projected 2024 inflation rate.



Cash assets are distributed across multiple financial institutions to reduce risk of loss and increase earnings. Last year \$240,000 was moved to Certificate of Deposit (CD) accounts at Collins Credit Union. All funds are fully insured, remain accessible on demand, and are earning 4-4.5% APY depending on CD maturity dates.

At the beginning of 2024, our long-time Treasurer/Bookkeeper/Office Manager retired, and the role was split into three positions for better internal controls, with the Treasurer being a Council position and the Bookkeeper and Office Manager as separate part-time paid positions. As with any change, it has been a challenging year for the accounting function, and we experienced turnover in both positions, but it has also been an opportunity to look at systems and processes with new perspectives and improve upon those.

Goals for 2025 include collaboration with the Property Committee to develop a comprehensive asset listing and strategic long-range planning of facility use, technology needs, capital purchases, and maintenance.

Thank you for your support that allows us to continue our ministries and spread the love of Christ.

AUDIT REPORT

2024 Audit Committee Report of 2023 Financials (Jon Lovseth, Pam Brown, Chrys English)

General Fund, Clearing, and Growth & Outreach Accounts. The committee compared the 2023 December Council report to the December bank reconciliation and the bank balances were confirmed with the bank. However, the grand total receipts and disbursements, of all funds given on the LCR cash summary, are estimated to be overstated by approximately \$40,000 because interfund transactions and voided checks were not eliminated from the receipts and disbursements.

The committee randomly selected two test months: March and November. Treasurer Esther Platt provided documents. The committee compared the checks written and checks cleared to the check documentation, account activity register, bank statement, and Council Summary with no exceptions. The disbursements appear reasonable and fit the ministry's purpose. All weekly deposits were accounted for and traced to the bank statement without exception.

Comforting Hands Quilters. Susan Conway provided documents for the audit. The checkbook balance matched the annual report and bank reconciliation at the end of the year. Deposits and distributions were reasonable and fit the ministry's purpose. Receipts were present for distributions and the deposit from LCR matched the disbursement on LCR's books.

ELCW Circle. Harriet Van Gilder provided documents for the audit. The checkbook balance was confirmed with the bank statement and matched the annual report and bank reconciliation. Deposits and distributions were reasonable amounts for items that fit the ministry's purpose.

Living Legacy (Trust) Fund. Jerry Cochrane provided trust fund statements, checking account statements, and checkbook ledger. The ending balances trust fund investments listed in the trust 2023 treasurer's report were compared to the Farmers State checking account, ELCA Mission Investment Fund CDs, and ELCA Endowment Fund Pooled Trust. The disbursements all appeared reasonable, fit the trust purpose, and the Endowment scholarship award did not exceed the fund's 4% limit. The Mission Investment Fund interest was entirely deposited and accounted for in the checking account. Records indicate all income in the endowment fund was reinvested.

The 2022 Trust Fund ending balance was \$209,458 vs. the \$204,123 reported in the annual report. This \$5,335 difference is because the ELCA pooled Trust Fund December statement balance was not received in time to be included in the annual report.

Wee Wisdom Preschool. Michelle Heidelbauer provided the documents. Since invoices were not available, the bank statements and payroll records were used to create an income statement and balance sheet for 2023. Based on the names of the vendors paid, the disbursements appeared reasonable for the preschool purpose. As of December 31, 2023,

the preschool had a net deficit of \$6,833 (Revenue \$27,293 less \$34,126 Expenses) and a bank balance of \$8,359. In 2024 our LCR bookkeeper will start maintaining the financial records since the preschool operates as a tax-exempt organization under the umbrella of the church's tax-exempt status.

General Internal Controls. The Treasurer and Office Manager positions were combined in 2012. The office Manager did everything: wrote and signed checks, maintained the general ledger, and reconciled the bank account. To establish better internal controls, Council members started reviewing invoices and signing checks in 2023.

RECORDING SECRETARY REPORT

The members and friends at LCR use many ways to support our church and community. See lcrmarion.org/giving for details on all our giving options. Giving using checks and cash remains the most common way to give, but several other methods have become popular.

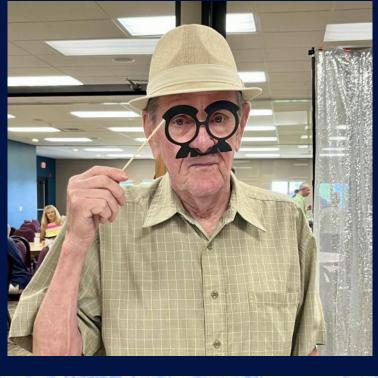
- Simply Giving EFT Currently 82 families use Simply Giving that allows for an automated contribution from your bank account every week or month. This accounts for 34% of our total offerings.
- PayPal & Venmo 5% of our contributions are made through PayPal or Venmo. These methods allow givers to contribute directly from their bank or credit card. These methods have become very popular for giving to special offerings throughout the year.
- **Distributions from an IRA** We've also continued to receive contributions from our older members who have discovered the tax advantages of using RMD funds for charitable giving. In 2024 we reached 15% of offerings received this way.
- Charitable Trusts 4% of our contributions have come from charitable trusts at the request of our members.

During this year's stewardship drive we again received pledges from 64% of our families. The data that we receive during the stewardship drive is essential in our budgeting process. While pledges are just one component of LCR's income, it has proven to be a very reliable indication of future income. So, the more pledges returned the less estimating is required.

You can continue to help us keep down our administrative costs in two ways. The first is by letting us know if you don't need weekly offering envelopes. The other way is by signing up to receive your quarterly statements via email. Please email me at the address below to make changes to offering envelopes and quarterly statement delivery or with any questions about your contribution statements.

TRUST FUND REPORT (LIVING LEGACY FUND

The Living Legacy Fund continues to have four associated funds:

- Biderman Scholarship for high school seniors
- Seminary Scholarship for seminary students
- Education Funds for pursuing religious learning opportunities and for educational programs
- Benevolent Giving for support of mission partners

No changes were made in committee members following the annual meeting on January 28, 2024. Jerry and Bonnie have completed three-year terms. Both have agreed to renew three-year terms.

Students who are LCR members and high school seniors may apply each spring for the Biderman Scholarship. Two graduating seniors, Emerson Fleming and Josephine McRoberts, were selected as recipients of this award for the 2024-25 school year.

Last year, our Seminary Scholarship recipient, Aaron Schutte, finished his education. Currently, no other candidates have pursued this opportunity. The Seminary Scholarship fund is still available for anyone interested in applying.

In August, the committee updated brochures entitled "LCR's Living Legacy Fund" and "LCR's Living Legacy Fund -Charitable Giving Through Your IRA-QCD." The brochures are posted in the gathering space. At Sunday church services in September, information was given on the four types of funds sponsored by the committee. On September 22nd, the committee hosted a display between services for anyone interested in more information on how to donate to the Fund. We also had available for members the "QCD - Qualified Charitable Contributions Worksheet" for planning contributions.

We sponsored Dr. Matthew Skinner as our guest speaker from Nov. 1st through 3rd. For the first time, an informal get-together was held on Friday evening at the Goldfinch Tap + Eatery. Following dinner, Dr. Skinner presented a talk, "The New Testament in 45 Minutes." Around fifty people attended! On Saturday, Dr. Skinner conducted a 10:00 am public presentation at the church and, later in the day, Pastor Jeff hosted a group of local clergy for an interactive session with our guest. On Sunday, Dr. Skinner preached at both church services. A chili and cinnamon roll lunch was shared after the second service, followed by Matt's parting comments. The Living Legacy Committee continues to accept donations for the Education Fund which supports visiting speakers.

The Advent theme this year was "Love's Pure Light." Since the focus is on in-kind donations, the committee will not be involved in any matching funds.

FINANCIAL REPORTS

INTRODUCTION TO 2025 BUDGET

I. Review of 2024

- Our original receipts estimate was \$840,000 a 4.2% increase from 2023 totals
- 2024 receipts were \$882,588 or 105% of our target of \$840,000
- 2024 expenses were \$792,600 or 94% of our 2024 budget of \$843,951
- We began the year with \$393,075 in the combined funds and ended the year with \$523,676
- On average we receive 101.5% of pledges as income and we base future receipts projections on that pattern. In 2024 we received 101.8% of pledges as income, compared to 98.4% in 2023

Takeaway - In 2024 expenses were lower due to lower than budgeted salaries related to staff transitions offset by expenses for our aging physical plant (sprinker system, AC, HVAC). As a result we added more to our cash balances that can be used in the future for anticipated/unexpected facility costs.

KEY HIGHLIGHTS OF THE PROPOSED BUDGET

2024 Gifts at Work

Total giving in 2024 was \$882,588. LCR distributed 10% of that amount (85,434.21) to the following global and local mission partners:

It is also our intention to share 10% of your gifts in 2025.

Pastoral Compensation: Pastor Jeff and Pastor Nate's wages were increased 8% in 2024. The proposed budget provides for a 1% increase in 2025.

Lay Staff Compensation: The proposed budget generally provides for a 2% wage increase for staff. Staff employed less than a year did not receive an increase. It also reflects a change in our Children's ministry director to a full-time position.

Facility Maintenance: The proposed budget provides for a 32% or \$23K increase over 2024 actuals for ongoing maintenance and some specific projects, including concrete leveling and repair, parking lot resealing, and furnace replacement.

Insurance: The budget reflects the actual 2025 insurance premiums which increased approximately 31% over 2024 (\$5K).

Budget Deficit: The estimated 2025 deficit of approximately \$12K is thought to be manageable due to the continued faithful giving of our members, the carry-over financial surplus from 2024, and continued careful stewardship by staff and the LCR Council.

The draft budget was presented to the church council for approval in December.
